On motion of Aaron Campbell & Calvin Glascock for letters of administration upon the estate of David Campbell and Charity Campbell relict of said deceased appeared in court and relinquished her right of administration and thereupon administration is granted into Aaron Campbell and Calvin Glascock who made oath thereto and together Joseph Smitherman & Elijah Campbell their securities entered into and acknowledged their bond in the penal sum of two thousand dollars conditioned according to law and thereupon a certificate is granted unto them for obtaining letters of administration in due form

Ordered that a warrant issue to James Sample Luke Rea and John Wilson to appraise the Estate the said David Campbell & return their appraise on oath to the administrators and that the administrators return the same to the clerks office of this court within thirty days.

At a Special Setting of the orphans court of said county at the court house at the temporary seat of Justice for the county aforesaid on Friday the 10th day of September one thousand eight hundred and twenty four present the Hon. Thomas Crawford Judge of the county court aforesaid. Aaron Campbell administrator of the estate of David Campbell returned an appraisement and Inventory of the Estate of the said deceased which is examined and ordered to be entered of Record.

On motion of Aaron Campbell administrator aforesaid and on the representation of the said administrator that a sale of the said Estate is necessary for the payment of debts and for equitable distribution - It is ordered that Aaron Campbell and Calvin Glascock administrators of the Estate of the aforesaid David Campbell deceased be and they are hereby authorized to sell the whole of the personal property belonging to said Estate which now has as hereafter may come into their hands by giving at least six months credit and after advertising the same at five publick places of said county at least thirty days previous to the day of sale and that they return an account their sales into the clerks office of this court within three months. At a regular return day of the orphans court of said County began and held on this first Monday day of October it being the second day of said month in the year of our Lord one thousand eight hundred and twenty six present Thomas Crawford Esquire Judge B C -- Whereas heretofore to wit on the 6th day of September A D 1824 Administration of the estate of David Campbell Decd was granted unto Aaron Campbell & Calvin Glascock by the Honorable the Judge of the County Court of Bibb County aforesaid And whereas also afterwards to wit on the 10th day of September 1824 Aaron Campbell & Calvin Glascock Administrators of aforesaid returned into the clerks office of the county court of the county aforesaid An Inventory & Appraisment of said estate amounting to the sum of seven hundred and seventy three dollars and two cents wherefore it was ordered by the Judge aforesaid that all the good and chattels contained in the bill of appraisment returned as aforesaid be sold as the law directs and that an account of such sale be returned to the clerks office with the time required by law And whereas also afterwards to wit on the 2nd day of January 1825 the Administrators aforesaid returned into the clerks office aforesaid an account of sales as ordered to be made (*next page*)

made as aforesaid amounting to the sum of five hundred and twenty two dollars and ninety cents. And the said Administrators States & Shews now here to the Judge that the residue of the Inventory except the goods & chattels sold is one hundred sixty three dollars & two cents which appears to be correct from reference now here made to the Inventory aforesaid. And now to wit at a Sitting and return day of process held by the Judge of the County Court of Bibb County at the Court House a the Temporary seat of Justice in & for said County on Monday the second day of October A. D. 1826. Aaron Campbell and Calvin Glascock Administrators of said estate produced their accounts against said estate for audition which accounts being audited by the Judge amount to the sum of one hundred & eight dollars & thirty two cents. And the account of sales & residue on the Inventory amount to the sum of six hundred and eighty five dollars and ninety two cents. And upon subtracting account against said Estate from the amount fo the sale Bill & Inventory. It is found & ascertained that he said Administrators have the sum of five

hundred & seventy seven dollars & sixty cents in their hands belonging to said Estate after paying all claims presented against said Estate And the said accounts being theirs audited and the same being examined & composed by the Judge aforesaid with the Inventory account of sales & vouchers And it appearing to the satisfaction of the Judge that legal notice has been given of the application for audition of the said accounts and allowance thereof to be decreed. And no exceptions being made to said accounts as audited. It is therefore Decreed that the said accounts as Stated & Audited be allowed. And it now appearing from the said accounts that there is now in the hands of the said Administrators the sum of five hundred & seventy seven dollars & sixty cents after paying all duly authenticated & presented Demands against said estate. And the Judge being now here sufficiently informed that the said David Campbell deceased left at his death a wife -- *(next page)*

wife Charity Campbell by name and Joseph Beasley and Elizabeth his wife late Elizabeth Campbell daughter of said David Campbell Decd And Elijah C Campbell Lacy Campbell Asa Campbell Joseph Campbell & John Campbell sons of said deceased infants within the age of twenty one all of whom are yet alive. It is therefore Decreed that the said Aaron Campbell & Calvin Glascock Administrators as aforesaid pay unto Charity Campbell widow & relict of the said David Campbell decd the sum of Eighty two Dollars and fifty one & 3/4 cents out the the said sum of five hundred and seventy seven dollars & sixty cents in their hands belonging to said Estate so being a childs part in fee simple of the personal estate & her distributive share of the personal estate as widow of the said David Campbell Decd. And it is further decreed that the said Aaron Campbell & Calvin Glascock Administrators as aforesaid pay unto Joseph Beasley & Elizabeth his wife late Elizabeth Campbell Daughter of the said David Campbell Decd the sume of eighty two dollars fifty one & 3/4 cents out of the said sum of five hundred and seventy seven dollars and sixty cents in their hands belonging to said estate it being the share descended to her from her Father the said David Campbell Decd of his personal estate And it is further decreed that he said Aaron Campbell & Calvin Glascock Administrators as aforesaid pay unto Elijah C Campbell infant orphan of the sd Decedant the sum of eighty two dollars fifty one & 3/4 cents out of the said sum of five hundred and seventy seven dollars and sixty cents in their hands belonging to said estate it being the share descended to him from his Father the said David Campbell decd of his personal estate. And it is further decreed that the said Aaron Campbell & Calvin Glascock Administrators as aforesaid pay unto Lacy Campbell infant orphan of the said David Campbell decd the sum of eighty two dollars fifty one & 3/4 cents out of the said sum of five hundred and seventy seven dollars and sixty cents in their hands belonging to said estate it being the share descended to him from his Father the said David Campbell decd of his personal estate. And it is further decreed that the said Aaron Campbell & Calvin Glascock Administrators as aforesaid pay unto *(next page)*

unto Asa Campbell Infant orphan of the said David Campbell decd the sum of eighty two dollars fifty one & 3/4 cents out of the said sum of five hundred and seventy seven dollars and sixty cents in their hands belonging to said estate it being the share descended to him from his Father the said David Campbell decd of his personal estate. And it is further decreed that the said

Aaron Campbell & Calvin Glascock Administrators as aforesaid pay unto Joseph Campbell infant orphan of the said David Campbell decd the sum of eighty two dollars fifty one & 3/4 cents out of the said sum of five hundred and seventy seven dollars and sixty cents in their hands of & belonging to said estate it being the share descended to him & from his Father the said David Campbell decd of his personal estate. And it is further decreed that the said Aaron Campbell & Calvin Glascock Administrators as aforesaid pay unto John Campbell infant orphan of the said David Campbell decd the sum of eighty two dollars fifty one & 3/4 cents the residue of the said sum of five hundred and seventy seven dollars and sixty cents in their hands of & belonging to said Estate it being the share descended to him from his Father the said David Campbell decd of his personal estate. All of which is adjudged ordered & decreed accordingly.
